The New Structure

You may well have noticed, from the 2015 editions of the ADIT Prospectus and Syllabus (as well as the website), that the various ADIT papers are now designated as **Paper 1**, **Paper 2** or **Paper 3** (rather than the previous Paper I, II, III designations).

The new designations form part of the changes to the ADIT qualification structure announced last summer, which are being introduced over the course of 2015 and 2016. Under the new structure, ADIT includes Paper 2 - Advanced International Taxation (Jurisdiction) and Paper 3 - Advanced International Taxation (Thematic) categories in place of the previous Paper II and III categories. The mandatory Paper I component remains unchanged, as Paper 1 - Principles of International Taxation.

The Paper 3 category now includes an expanded range of thematic options, while the new structure will, from June 2016, offer students the choice of **any two option papers** in addition to Paper 1. For full information about the changes, please visit **www.adit.org.uk/aditischanging**.

Last Chance for Paper 3.05

The June 2015 exam session will be the last opportunity for students to sit the Paper 3.05 United States option. This paper is to be withdrawn from the syllabus as the Paper 3 options focus on **thematic** areas of international tax. The existing Paper 2.10 United States option will remain available as a **jurisdiction** paper. Students who have completed Paper 3.05 will retain this pass under the new structure.

ADIT Network: My International Tax Life

I am currently the team leader of Transfer Pricing and Market Entry services in Deloitte

Vietnam's Ho Chi Minh City office. My team and I assist clients on TP compliance matters, providing advisory services on cross border transactions. We work closely with other Deloitte offices around the world, especially in Singapore, Australia, Germany and UK, for the consistent TP policies of our group clients. For Market Entry services, my team assists the client on providing tax and regulatory advice. We provide advice to new and existing clients

on business structuring in Vietnam, and the tax implications of their business activities.

I obtained my TP certificate in August 2011, and this helped me in getting to my current position. When I completed ADIT in August 2013, it was really exciting as I was the first Vietnamese student to achieve ADIT. I have been recognised by colleagues overseas, and invited to deliver training to Vietnamese authorities in the financial sector. I am now preparing materials to deliver training on international tax and TP for MBA courses in 2015. My next goal is to obtain an overseas position in international tax and TP or Australian tax, for which my ADIT experience will again be an advantage.

Quang completed ADIT in 2013, and currently works as a Tax Manager at Deloitte in Ho Chi Minh City, Vietnam.



ADIT Network: Guest Article

ADIT students share their advice...



In the latest contribution to our guest article series, ADIT tutor Narelle McKenzie – who delivers courses covering the United States option papers – shares some useful exam preparation tips and strategies collected from successful ADIT students.

Towards the end of each course that I have delivered, I ask participants – particularly those who have been successful in other papers – to share their tips on studying for ADIT exams.

One tip on advance preparation is to use highlighters to colour-code each relevant part of the tax code/ legislation. This is generally the only text book you are able to take into the exam, and the colourcoding provides for easy reference during the time crunch of the exam. For example, for the United States option papers you are able to bring in the code and associated regulations, and the United States papers focus generally on inbound and outbound issues. For outbound issues, you are dealing with the subpart F rules - so would highlight the relevant part of the code and regulations in one colour. For the inbound rules, you would look to the thin capitalization and branch profits tax sections of the code and regulations and use another colour. The rules regarding the use of text in ADIT exams are strict, of course: you may highlight and underline, but you must not annotate or use tags.

Next, make use of past papers. This will enable you to look up the court and code citations, and quickly identify the relevant parts of the tax treaty for points to support the position you take in your responses. Examination of past papers reveals a pattern to the style of questions asked, so you can usefully practice drafting responses and time yourself, making sure that you are sticking to the 45 minute time cycle for answering each question in most ADIT exams exam.

A successful candidate will not only demonstrate an understanding of the relevant law, but should also show an awareness of current developments, so ensure you understand the current hot topic in the international area of the paper you are sitting. For example, for the United States papers in 2015 I would suggest being conversant with the September 2014 Notice on inversions. I also recommend learning the impact of FATCA on payments made by US persons to non-US persons, as the FATCA rules override tax treaties.

During the exam, ensure you strictly allocate your time so that you have sufficient time to address each question. For example, in the Paper 3.05 United States option exam, you have to answer two questions from a choice of three questions in Parts I and II. It's a good idea to determine which question you least want to answer – so spend the first few minutes of the reading time scanning through the options. You should then allocate 45 minutes to each question.

In contrast, to complete the Paper 2.09 United States option exam you must answer all questions. Here, you should rank the questions in order, starting with your least favoured question. Note the issues and analysis so that you have something recorded as a response (spend five minutes or so doing this), and then start addressing the question that you know best and work back through the list. Again, it makes sense to allocate equal amounts of time to each question, but by having spent 5-10 minutes recording some response for your least desirable question you relieve some of the stress of dealing with it.

While I am most familiar with the United States papers, the above tips from students also apply to other papers, and I wish every person sitting the ADIT exams in 2015 the very best of luck with their studies.
